October 2023 marks the two-year anniversary of the adoption of the <u>CONNECT</u> <u>Beyond Regional Mobility Plan</u>, and during this time focus, has been on the implementation of the plan's key near-term <u>recommendations</u>. One of the most important and impactful recommendations is the development of a regional transportation demand management (TDM) plan and program. Centralina is leading the effort on this recommendation.

## **Project Updates**

#### Seamless CONNECTions





Several CONNECT Beyond recommendations related to emerging technologies call for regional coordination on the deployment of these technologies to improve connectivity and service. One group working on this topic is the **Connected Autonomous Vehicles (CAV) Task Force**, which meets quarterly to discuss the current and future impacts of CAV technologies to our region. Recently, Centralina convened the CAV Task Force on November 6th in conjunction with a demonstration of the <u>CASSI shuttle program at UNC Charlotte</u>. In addition to taking a ride on the CASSI shuttle, CAV Task Force members heard presentations on the future capabilities of these automated vehicle technologies and how to prepare for them.

# **Upcoming: Active Transportation Infrastructure Investment Program**

For those interested in funding active transportation projects, keep an eye on the <u>Active Transportation Infrastructure Investment Program</u>, a competitive grant program created by the Bipartisan Infrastructure Law. The focus of the funding will be on connecting destinations and communities with active

transportation and integrating active transportation into transit services. The NOFO is expected Fall 2023.

#### **NCDOT Interim Design Safety Pilot Program**

The NCDOT Interim Safety Pilot Project deploys low-cost, interim design safety countermeasures on state owned and maintained roadways. This program emphasizes safety countermeasures that can be deployed rapidly to protect pedestrians and bicyclists. Check out the final report.

### Plan in Action: Local Successes

#### 2023 Safe Streets and Roads for All (SS4A) Grant Recipients

Congratulations to the **City of Gastonia** and the **City of Monroe** for being 2023 SS4A grant recipients. Both jurisdictions received grant funds to develop safety action plans – a key element to helping communities plan and design safer streets and a part of USDOT's <u>National Roadway Safety Strategy</u>. #### Climate Pollution Reduction Grant: Call for Interest

Centralina Regional Council received a \$1 million planning grant through the U.S EPA's **Climate Pollution Reduction Grant Program**, a two-stage grant program that includes funding for noncompetitive planning grants and competitive implementation grants. Our staff will serve as the lead entity for the 13-county, bi-state area and will prepare a series of plans designed to support local needs and priorities toward improving air quality and reducing greenhouse gas emissions. **Many of the CONNECT Beyond recommendations could be supported through this program**. #### **Regional Infrastructure Accelerator Grant Announcement**

In October, Centralina learned it was a recipient of a Regional Infrastructure Accelerator grant from the US Department of Transportation (US DOT). Centralina received \$1.75M in funding for CONNECT Beyond implementation, including establishing an *Integrated Mobility Center* and building out project service lines for finance innovation, pipeline project facilitation and transit orientated development.
